

Mi6IT Sàrl Privacy Policy and Code of Conduct - v1.17.04.2018

Date of entry into force: 18/04/2018

Preamble :

Notwithstanding the implementation of Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of physical data with regard to the processing of personal data and on the free movement of such data, with an official implementation date of 25 May 2018, Mi6IT Sàrl attaches the utmost importance to respect for privacy, national rules, laws and European directives.

The purpose of this privacy policy is to describe the way Mi6IT Sàrl operates with regard to the confidentiality of the data collected.

Mi6IT Sàrl invites you to regularly consult this privacy policy available on its website or available on request.

Why we collect personal data:

Mi6IT Sàrl collects personal data in order to provide the best services to all natural and/or legal persons likely to call upon its professional skills.

The collection of personal information allows Mi6IT Sàrl to carry out its missions but also to facilitate your access to its products and services. Moreover, thanks to the collection of this data, Mi6IT Sàrl is able to keep you informed of the evolution of its services and events likely to interest you.

Type of collections and use of information:

Without this list being exhaustive, below is reproduced the list of the most frequent cases of collection of personal data:

- Personal information may be requested during a telephone discussion or an interview with one of our employees about a business issue, downloading a software update, registering for an event, participating in a survey, purchasing a product or service, requesting a repair, etc.
- During these same exchanges, Mi6IT Sàrl may also ask you for more personal data but nevertheless related to the situation such as, your name, postal, business, delivery, billing addresses, telephone numbers, one or more email addresses, contact preferences, bank details etc.
- Information on the products purchased from Mi6IT Sàrl such as date, reference, warranty period, serial number, payment date, proof of payment, type of service level agreement chosen etc..
- Mi6IT Sàrl may also collect information for statistical purposes in order to always be able to refine its commercial offer and remain competitive in a highly competitive environment.
- Whatever the case and whatever the type of information collected, Mi6IT Sàrl, undertake to protect by all technical and organizational measures the confidentiality of the data collected,

never to disseminate or make them public or sell / rent them without your consent unless the need requires it for the proper execution of the order or contract.

Limited disclosure of information collected:

Mi6IT Sàrl may have to share some of the information collected with its own service providers, suppliers, legal advisors or strategic partners.

These same partners can help Mi6IT Sàrl to process information, execute orders, deliver products, provide a support service, market products, grant credits, conduct satisfaction surveys.

Public nature of publicly displayed information:

Mi6IT Sàrl draws your attention to the public nature of information posted publicly via chats, forums, online conversation services etc.. In this case Mi6IT Sàrl cannot be held responsible.
